Marketing:

David Schwartz mentioned that he was at the Tarrytown Regional in January, and was very upset because he saw flyers for future Regionals at different locations, but there were none from our district's Regional displayed. We were advised that posters were made, but were lost. Lewis Grossman agreed to have new posters printed. Mark Blanchard will be attending Regionals throughout the northeast (Danbury, Lancaster, Cambridge MD, Mansfield MA, and Cleveland) and will be distributing our flyers at those locations.

<u>The Islander</u>

We will continue to present the Islander on line. Submissions for articles should be made by March 1, 2018.

Grand National Teams:

Joe got the GNY to have club qualifying in Flight C. Unit 242 ran no qualifying games. The City has had qualifying games and they have gone very well.

North American Paris:
